CONTRACT TERMS AND CONDITIONS FOR EXHIBITORS

1. The Exhibitor agrees to pay the price indicated on or before the due date.
2. The Exhibitor shall insure his own merchandise against fire, theft and all perils. Exhibitors are required to maintain public liability insurance to a minimum of \$2,000,000.00. Proof of insurance is mandatory.
3. Master Promotions Ltd., or Event Sponsor (Sponsors), are not responsible for any loss incurred by any Exhibitor.
4. Exhibit space will be made available for Exhibitor's use, on a scheduled basis, prior to opening.
5. Exhibit to be completed by the Exhibitor for official inspection by *9:00 p.m., Wednesday, September 19, 2012.*
6. Preparation of the Exhibit will be at the Exhibitor's expense.
7. Exhibit will remain intact until *5:00 p.m., Saturday, September 22, 2012.* No removal or dismantling of the Exhibit or Exhibit Material is permitted before this time.
8. All exhibit activities must be kept within the confines of the rented exhibit space.
9. Final allotment of Booth space will be at the discretion of Show Management.
10. Space is to be used for products and purpose of Exhibitor and cannot be sublet or used by other than the Exhibitor without written consent of Show Management.
11. A non-refundable deposit of 50% at the time of application is required. The balance will become due, and payable, on or before *July 27, 2012.* All monies received prior to the completion of the event will be considered a deposit. When payments for space are not paid when due, deposits may be forfeited and the space re-allocated.
12. Cancellation Policy — Due to the nature of this event and the commitment of preparing the site, the Exhibitor will be required to pay the full cost of the contracted space.
13. The Exhibitor must occupy the space allocated to him during his scheduled move-in time, unless otherwise approved by Show Management.
14. Goods may not be delivered, or removed, from the site during show hours.
15. All applicable Provincial and Federal Taxes at the time of the event are the sole responsibility of the exhibitor.
16. The sale of raffle tickets, lotteries and/or gambling is not permitted.
17. The Exhibitor agrees to abide by all rules and regulations set forth by Show Management and the Commission de la santé et de la sécurité du travail du Québec, at the Exhibitor's own expense.
